



## GRACE POINT FACILITY USE RULES & REGULATIONS

- **ALCOHOLIC BEVERAGES, ILLEGAL SUBSTANCES & FIREARMS ARE NOT PERMITTED UNDER ANY CIRCUMSTANCE.** These shall not be brought to the properties nor consumed on the property. Any person believed to be intoxicated at any extent will be removed from property.
- **PROFANITY AND ABUSIVE LANGUAGE.** This will not be tolerated at any level.
- **ATTENDANCE BY A RESPONSIBLE PERSON.** A responsible person shall be at all functions held within Grace Point facilities. This person shall work cooperatively with Grace Point personnel to insure proper care of property and enforcement of regulations. Applicant accepts responsibility for any damages that might occur during use. The applicant agrees to release Grace Point/Get Real staff from any and all claims for injuries of persons incurred while using the facilities.
- **POSTED RULES & INSTRUCTIONS.** Please follow any rules & regulations posted on walls, etc.
- **GAMBLING:** Participating in any kind of gambling is not allowed.
- **CLOTHING:** Appropriate shoes & shirts required at all times. Shirts must be worn at all times.
- **GROUND AND PROPERTY.** Grace Point property shall not be moved or removed from premises. Grace Point personnel reserves right to inspect the premises during any activity.
- **PETS.** Pets are not allowed in the community buildings. All pets must be kept on a leash. Please clean-up any waste and dispose of properly.
- **SMOKING/ TOBACCO USE.** Grace Point is a TOBACCO-FREE campus. This includes any form of tobacco.
- **FEES/ CHARGES.** Batting Cages: \$25 per hour for group use. Field Lights: \$25 per hour.
- **DATE CHANGES:** Please notify us immediately if you need to cancel or change your scheduled time of use.
- **BUILDING POLICY:** The using organization/individual is responsible for the building and building's contents during use. The building must be left in the condition in which it was found. Any user leaving the facility unattended will be held responsible for any damage or theft that occurs. Building requires presence of Grace Point staff.
- **UNDER 18 YEARS:** Required accompaniment by parent, legal guardian or group leader.
- **CLEAN-UP:** Please clean-up after every use. Please place trash in all appropriate receptacles.

### GENERAL USE POLICIES

*Use of Grace Point facilities is at your own risk.*

*User assumes all liabilities and must sign waiver prior to participating in events, etc.*

### FIELDS

- Do not mark any fields without permission of Grace Point staff.
- No motor vehicles are allowed on fields without permission of Grace Point staff.
- Appropriate athletic wear is required at all times. Shirts and shoes must be worn at all times.
- Please clean up any trash found on the fields/ left by visitors and place in appropriate trash receptacle. Please take all trash bags with you upon departure.

### WEIGHT ROOM

- Spotters are required for all free-weight bench presses, shoulder presses, dumbbell presses and squats.
- If equipment is dirty after you use it, please clean it up.
- Appropriate athletic wear is REQUIRED for training.
- Appropriate footwear is REQUIRED for training. Boots, open-toed shoes and sandals are not permitted during training.
- DO NOT remove any equipment or weights from training room under any circumstance.
- If you mess it up-clean it up.

**Volunteer Release & Waiver of Liability**

***Please read carefully! This is a legal document, which affects your legal rights!***

The participant desires to work as a volunteer for Grace Point/ Use Facilities available and engage in the activities related to being a volunteer/participant.

The individual patrons understand that they shall utilize all recreational facilities/volunteer for services at their own risk. The individual understands that Grace Point, it's staff, it's volunteers do not assume liability for property loss and or injuries resulting from any activity or event.

The Volunteer does hereby freely, voluntarily and without duress execute this Release under the following terms:

**1. WAIVER AND RELEASE**

Volunteer does hereby release and forever discharge and hold harmless Grace Point, its affiliated organizations and its successors and assigns from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arises or may hereafter arise from the Participant's work/participation for Grace Point. Volunteer understands that this Release discharges GP from any liability or claim that the Volunteer may have against GP with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's work for Habitat whether caused by the negligence of Grace Point or its affiliated organizations, officers, directors, employees, agents or otherwise. Volunteer also understands that, except as Grace Point has disclosed in writing, Grace Point does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance, in the event of injury or illness.

**2. MEDICAL TREATMENT**

Volunteer does hereby release and forever discharge Grace Point from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the participant's work for Grace Point.

**3. ASSUMPTION OF THE RISK**

The Volunteer understands that GP's work may include activities that may be hazardous to the Volunteer and that the food, accommodations and medical facilities may be donated to Grace Point and beyond the control of Grace Point. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases Grace Point from all liability for injury, illness, death or property damage resulting from the activities of the participant/volunteer's work for GP.

**4. INSURANCE**

Grace Point does not carry or maintain, and expressly disclaims responsibility for providing any special health, medical or disability insurance coverage for the Volunteer/participant. EACH VOLUNTEER IS EXPECTED AND ENCOURAGED TO ARRIVE WITH MEDICAL OR HEALTH INSURANCE COVERAGE IN EFFECT.

**5. PHOTOGRAPHIC RELEASE**

Volunteer does hereby grant and convey unto GP all right, title and interest in any and all photographic images and video or audio recordings made by Grace Point during Grace Point's work, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.

**6. AGE RESTRICTIONS**

Volunteers under 18 years old agree not to use any power tools or work from heights (on a roof or on scaffolding) on the construction site. Adult supervisors accompanying those under 18 years of age assume responsibility of compliance.

**7. OTHER**

Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia, and that this release shall be governed by and interpreted in accordance with the laws of the State of Georgia. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by a court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
